 Your affiant, a detective with the Indian River County Sheriff's Office, was assigned to investigate this case in which defendant Kaitlyn Hunt (18 year old female) penetrated victim (14 year old female) vagina with her finger.

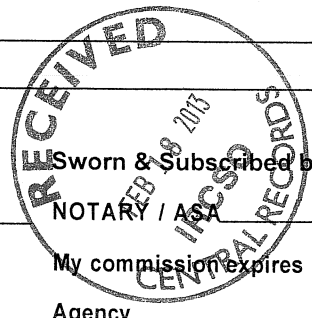
On February 15, 2013, your affiant conducted an interview with (14 year old female). The following is a summary of that interview.

(14 year old female) met Kaitlyn at Sebastian High School due to them both being students there. They started dating in November of 2012 and began a sexual relationship before Christmas of 2012. The first time occurred in the bathroom of the W wing at Sebastian River High School. (14 year old female) stated that they sent text messages to each other to meet in the bathroom. (14 year old female) and Kaitlyn went into a bathroom stall and started kissing. Kaitlyn then took (14 year old female)'s pants off and put her finger inside of (14 year old female)'s vagina.

(14 year old female) stated that the last time was approximately one month ago. She told your affiant that she and Kaitlyn went into the same bathroom and Kaitlyn again put her finger inside of (14 year old female)'s vagina.

█ told your affiant that there was one occasion that she ran away from home in January of 2013. Your affiant researched this and learned that she ran away on January 4, 2013. █ stated that Kaitlyn picked her up and took █ back to Kaitlyn's house at 231 Stony Point Drive, Sebastian, Florida. That night, while in Kaitlyn's bedroom, █ and Kaitlyn put their fingers inside of each other's vaginas, put their mouths on each other's vaginas, and both of them used a vibrator on each other to insert it in each other's vaginas.

On February 15, 2013, your affiant conducted a controlled phone call between █ and Kaitlyn. The following is a summary of that phone call.

During the phone call, █ told Kaitlyn that she was her first person having sex with and asked Kaitlyn if it meant anything to her. Kaitlyn said that obviously it meant something to her. Kaitlyn told █ that she has never been in love with anybody else like her. █ asked Kaitlyn if she remembered the first time they had sex and asked if it meant anything to Kaitlyn and Kaitlyn said obviously.

On February 16, 2013, your affiant arrested Kaitlyn and had her transported to the Sheriff's Office. Your affiant conducted an interview with Kaitlyn. The following is a summary of that interview.

Your affiant read Kaitlyn her Miranda Rights from a Miranda Rights warning card. She stated she understood and would speak with your affiant.

During the interview, Kaitlyn stated that her sexual relationship with █ began after Christmas of 2012. Kaitlyn confirmed that she and █ did go into the bathroom at school and she did put her finger inside of █'s vagina. Kaitlyn also confirmed that she put her finger inside of █'s vagina the time that █ ran away from home and they met up. Your affiant asked Kaitlyn if she knew it was wrong to have sex with █ due to █ being 14 years old. Kaitlyn stated that she did not think about it because █ acted older.
